

### **Favorable Seventh Circuit Court of Appeals**

*Sarchet v. Chater*, 78 F.3d 305 (7<sup>th</sup> Cir. 1996), ALJ Helen Thomas – fibromyalgia – seminal case, as this is the first appellate case in the United States finding fibromyalgia is a medical condition for which Social Security disability benefits could be awarded.

*Kellems v. Commissioner*, 382 Fed.Appx 512 (7<sup>th</sup> Cir. 2010), ALJ David Thompson – fibromyalgia; ALJ erred by concluding claimant’s misuse of prescription medications was anything but proper.

*Abbott v. Astrue*, 391 Fed.Appx. 554 (7<sup>th</sup> Cir. 2010), ALJ John Wood – VE testimony not accurate regarding transferability of job skills.

*Price v. Colvin*, 794 F.3d 836 (7<sup>th</sup> Cir. 2015), ALJ James Craig – depression and anxiety; failure of the ALJ to consider the reasons the claimant was previously on Social Security disability.

*March v. Commissioner*, 2015 WL 12683829 (C.D. Ill 2015), ALJ Robert Schwartz (remanded by agreement with the Commissioner upon initial briefing by Plaintiff in the Seventh Circuit Court of Appeals, Cause No. 15-2898, reversing the decision of District Court Judge Colin S. Bruce, Central District Court No. 14-2083 - judgment for March on February 2, 2016)

*Baldwin v. Commissioner*, 746 Fed.Appx. 580 (7<sup>th</sup> Cir. 2018) (unpublished decision) ALJ Robert Schwartz – ALJ cherry-picked the medical record, reversing the decision of Magistrate Judge Eric I. Long.

*Delonjay v. Commissioner*, Seventh Circuit Court of Appeals, 18-2268 (November 8, 2018) ALJ Stephen Hanekamp, remanded by agreement with the Commissioner upon initial briefing by Plaintiff in the Seventh Circuit Court of Appeals, Cause No. 15-2898, reversing the decision of Hon. Tom Schanzle-Haskins, Magistrate Judge, 2018 WL 17855496 (2018 CD Ill. April 13, 2018) – mandate issued by Appellate Court on November 13, 2018.

*Hardy v. Commissioner*, 908 F.3d 309 (7<sup>th</sup> Cir 2019), ALJ Susan Sarsfield – failure to properly weigh medical opinions, reversing the decision of Hon. Tom Schanzle-Haskins, Magistrate Judge.

*Miller v. Commissioner*, Seventh Circuit Court of Appeals, 18-3061, ALJ David Thompson – remanded by agreement with the Commissioner upon initial briefing by Plaintiff in the Seventh Circuit Court of Appeals, Cause No. 15-2898, reversing the decision of Hon. Eric I. Long, Magistrate Judge, 2018 WL 17855496 (2018 CD Ill. April 13, 2018) – mandate issued by Appellate Court on September 3, 2019.

*Gibbons v. Commissioner*, Seventh Circuit Court of Appeals, ALJ Kathleen Laub (January 23, 2020). The ALJ’s decision was not supported by substantial evidence by relying on an opinion that predated the worsening of the claimant’s pain symptoms.
